# Singapore to Impose Sanctions on Russia

### Introduction

On 28 February 2022, the Minister for Foreign Affairs, Mr Vivian Balakrishnan, issued a Ministerial Statement in Parliament stating that Singapore intends to impose sanctions and restrictions against Russia (available <a href="here">here</a>). The potential imposition of country-based sanctions against Russia, in the absence of any underlying United Nations Security Council resolution, is an unprecedented step in the implementation of Singapore's foreign policy.

# **Scope of Prospective Sanctions**

While we await the issuance of the relevant primary and/or subsidiary legislation, the Ministerial Statement suggests that Singapore's prospective sanctions may mirror, to some degree, recent sanctions issued by the United States, the European Union, the United Kingdom, and Japan. There is some uncertainty in this regard given that each sanctions regime differs from jurisdiction to jurisdiction.

Nonetheless, the Ministerial Statement also suggests that such prospective sanctions will include blocking certain Russian banks and financial transactions connected to Russia, as well as export controls on items that could be used as weapons against the people of Ukraine.

Additionally, the prospective sanctions may also potentially include the imposition of asset freezes, and/or a prohibition on making funds available to or for the benefit of certain individuals or entities. There is also the possibility that any prospective sanctions will mirror the language of any United Nations General Assembly ("UN GA") resolution, pending the outcome of the UN GA debate later tonight (28 February 2022, Singapore time).

# **Concluding Remarks**

In light of the Ministerial Statement, banks and other participants in the energy, shipping, defence, and private wealth sectors would be well-advised to identify and ascertain whether there are any live or upcoming transactions with any links with Russia. Such links could include, without limitation, letters of credit issued or confirmed by Russian banks, as well as transactions involving Russian counterparties and ports. This is particularly since it is not clear whether any sanctions, when imposed by the Singapore Government, will have any winding-down period before they take effect.

We will continue to monitor developments and will provide further updates once the relevant legislation has been enacted.
